BOARD OF COUNTY ROAD COMMISSIONERS OF THE COUNTY OF CASS

SUBJECT: PERMIT FEE SCHEDULE

ADOPTED BY BOARD ACTION 8-05-10 (PUBLIC HEARING HELD)

Pursuant to Public Act No. 283 of 1909 (MCLA 224.196) and public hearings held, the Cass County Road Commission has determined the following fee schedule to recoup costs actually incurred in processing permits. The following schedule is not meant to be all inclusive in recouping all costs, and therefore may be increased to cover the actual costs incurred.

ABANDONMENT

1. Petitioner is the only abutting owner & the road, street, or alley has never been used for access to other property
300.00
2. More than one other abutting owner the road, street, or alley has never been used for access to other property
500.00
3. More than one abutting owner & where the records, such as a plat or local reputation indicate the road, street, or alley has been used for access to other property
750.00

*A permit fee can be waived upon request of the applicant and the approval of the Board.

IMPORTANT INSURANCE INFORMATION

All permits require \$300,000 General Liability Insurance EXCEPT pier permits, which require \$500,000 and Sewer Installations which require \$1,000,000. Insurance requirements MAY be waived by the Board of Road Commissioners.

Effective 8/93 Permit issued to individual doing own work requires a certificate of insurance naming the Cass County Road Commission as certificate holder. Contractor doing the work requires a certificate from the contractor naming the Cass County Road Commission, Commissioners, and employees as additional insured.
